- 1. Welcome & Call to Order Joe Thomas called the meeting to order at 8:03 am and introduced Diocesan Director, Karen Dehais. Karen expressed her gratitude and gave her background.
- 2. Prayer/Poem/Positivity Joe Thomas led with an opening poem.

## 3. Approval of the December 8, 2021 Minutes

Mary Pat Dolan made a motion to approve the December minutes. Steve Hoyt seconded. None opposed. Minutes approved.

- 4. Check-in Committee members and staff provided updates on their personal & professional lives.
- 5. Client Survey Results Jen Bertron reviewed Client Survey results which included the following: Core Outcome Themes; Survey of Current Clients and Lapsed Clients; Last Service Received; County Served; Net Promotor Score or how likely to recommend our services; Good Food Indicators; Preferences; Variations Across Services; Increasing Access; Client Experience; Food Finder Use; Barriers to Access for Current Clients and Lapsed Clients; Strategic Collaboration Indicators; Client Experience; Client Interest in Collaboration. Jen concluded with the following next steps: Additional Survey Analysis; Focus Groups/Targeted Surveys; Comparing Demographics; Agency & Community Partner Survey; Setting Short Term Goals; and a Final Presentation to the BOD February 17.

The group discussed the following: MFP operations and client choice; Initial planning stages of Order Ahead; Challenges getting food for those who do not own phones; Developing strategy for Enfield and Broome County participation in PantryTrak; Improving client experience; Building relationships with those who serve the underserved and an Expanded definition of partner and who we should be working with to serve more people (libraries, Head Start).

6. Spending Down SIF Funds – Joe Thomas reported that we will present a plan for SIF spending at the February 17, BOD meeting. Natasha elaborated by pointing out that carryover funds will be spent in 2022 and we will present plans to the Executive Committee in February for spending through 2023. The plans, and two additional SIF proposals, will be bolstered by Client Survey data and metrics around proposed impact. Natasha added that the SIF Kitchen Cabinet will present updates – noting the top 3-5 learnings and future goals – which will become the foundation for educating the BOD about SIF work.

## 7. Follow-up Items

**Strategy Committee Charter** – Natasha reviewed the ad hoc Strategy Committee draft charter which was followed by Committee discussion.

**CEO 2021 Performance Report –** Natasha reviewed her 2021 Performance report which will accompany the 2021 CEO Performance Appraisal at the end of January. The group noted that this has been a great year for Natasha. Joe added that he and Karen Dehais will meet to review Appraisal results and present a summary of

the results to the Executive Committee, BOD, and Natasha in February.

## **STRATEGY COMMITTEE (Ad-hoc)**

## **PURPOSE:**

The purpose of the Strategy Committee is to oversee the development and implementation of the Food Bank's Strategic Investment Fund (SIF) in cooperation with the Board of Directors (BOD), President & CEO and staff.

#### **RESPONSIBILITIES:**

- 1. Oversee the development and implementation of the Food Bank's Strategic Investment Fund (SIF) initiatives.
- 2. Review SIF progress reports and provide feedback as needed. Keep the full BOD informed through regular reports at quarterly meetings.
- 3. Provide guidance and direction on program development and design with an emphasis on client engagement, data analysis, and evaluation.
- 4. Identify potential partners that might be able to assist with or benefit from SIF priorities. Make introductions as needed.
- 5. Assist staff with planning and facilitating BOD education and communication around the SIF.
- 6. Ensure SIF funds are allocated and spent according to their original intent.

## **HISTORY:**

The Food Bank raised an unprecedented amount of funds in 2020 in support of our COVID relief efforts which resulted in an operating surplus of over \$5M. The board charged the staff to develop a plan to spend down the funds in the spirit of donors' intent. The Senior Leadership Team (SLT) proposed the creation of a Strategic Investment Fund (SIF) to support new and innovative projects to address at least one of more of the following: 1) strategic priority, 2) needs assessment recommendation, or 3) building our internal capacity. Staff were encouraged to submit project proposals which were reviewed and scored by the CEO, COO and CDO. The selected projects were shared with the board for final approval. Most projects have an initial three-year time horizon. We have assembled a SIF Kitchen Cabinet comprised of SIF project leads and SLT members to help move the work forward, maintain accountability, and facilitate learning among members. The Strategy Committee will be the liaison between the SIF Kitchen Cabinet and the full Board.
