- 1. Welcome & Call to Order Grace Park called the meeting to order at 8:32 am
- 2. Prayer/Poem/Positivity Mary Pat Dolan shared a poem

3. Approval of November 30, 2021 Meeting Minutes

Maureen Ferrell made a motion to approve the November 30, 2021 minutes. Fred Van Sickle seconded. All were in favor. None opposed.

Worked really well for me over the past nine years.

2. What have been your most positive experiences? Have you had any disappointments?

Proud of the fact that I helped contribute to increase awareness about the Food Bank in Broome County. Disappointments: Not being able to open enough doors e.g. Joe Mirabito & Bruce Boyea intros didn't happen. Also didn't find my replacement before leaving the BOD.

4. How did we tap into your personal passions and expertise to advance the organization's mission? I do! That's a good way to put it.

In accordance with Article III, Section 3, Paragraph b of the Food Bank's by-laws, Directors shall be elected for terms of three years, which terms shall be divided as nearly as possible into three classes of Elected Directors so that each year only about one-third of the Elected Directors' terms will expire. An Elected Director may not serve more than three consecutive three-year terms. Members are elected at the Food Bank's annual meeting in February.
