- 1. Welcome and Call to Order: Chairperson Fred Van Sickle called the meeting to order at 8:30 a.m.

6. Move December N&CG Meeting to November 2nd or 9th

The N&CG Committee needs to meet to approve a slate of Board members and officers before the November 30th Board meeting. After discussion, the Committee decided to have a short meeting on

November 9^{th} at 8:00 am to finalize and approve Board slates, and to cancel their scheduled December meeting.
