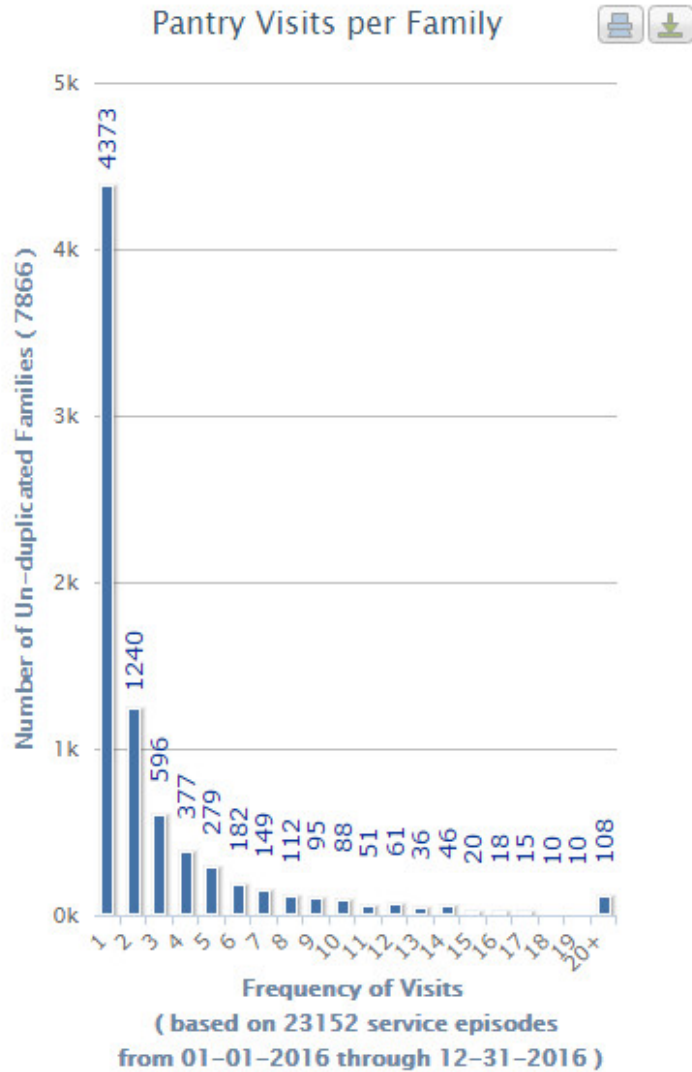

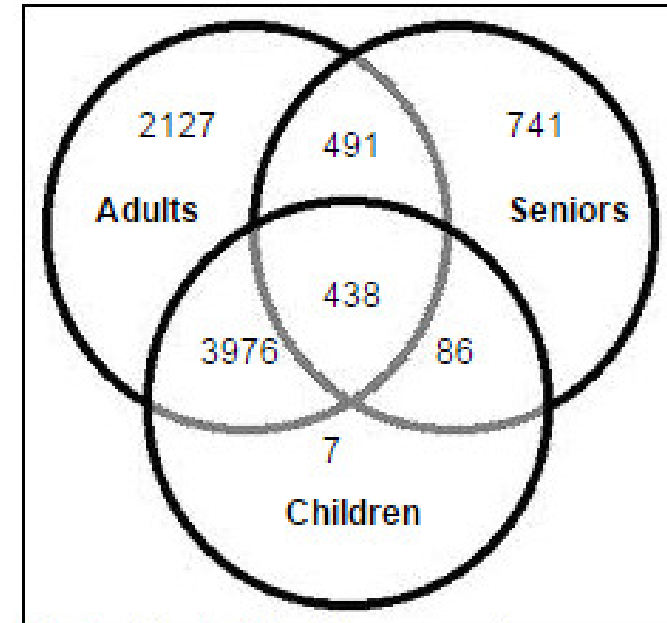
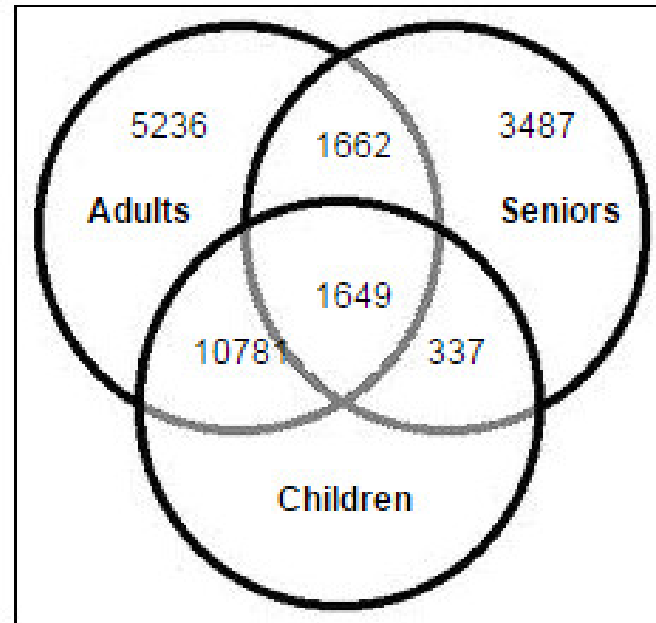

Ground Rules for Intake

GOALS:

- 1) Maintain **privacy** of client and their information
- 2) Make clients feel welcome
- 3) Obtain accurate information about who we are serving
- 4) Be efficient



PRACTICE 1.0



Everyone practice entering two new clients and checking in two existing ones.



Scenario #1



A client says they have been to the Pineapple Mobile Food Pantry distribution before, but this is their first time at your site. They have never been given a key tag.

Look them up in PantryTrak. If they are not in the system, have them fill out a new client sheet. If they are, double check that they don't have a key tag in the system, and assign them one.



Scenario #2

A client says they have lost their key tag.

- 1) Reassure them.
- 2) Search for them by name.
- 3) Mark them as served.
- 4) Inactivate their first key tag.
- 5) Assign them a new one.



Scenario #3



A client hands you their key tag, you scan it, and no record comes up.

FIRST, check that the Alt-ID box is orange AND that your cursor is blinking in the box above it.

THEN, look them up by their name. Mark them as served. Add the keytag as if you are adding it for the first time. This means someone forgot this step, but now they're all set for next time.

Scenario #4

The Internet isn't working / PantryTrak isn't working / I think we might be entering something wrong.

- 1) Remain calm 😊
- 2) Call Kathryn or Jackie.
- 3) If necessary, make a list of key tags and names for those with both. For everyone else, collect registration forms and give them key tags.



Scenario #5

A client does not want to give me their address / name / birthdate, etc.

- 1) Explain what we use the data for. It is NOT used in association with their name, but just to give aggregate data about how many people are being served, how big their households are, etc. so that we can better serve them.
- 2) If they are still unwilling to share information, do not push them. If we can't get a birthdate, try for an age, and if we can't get that, use a placeholder age. If they don't want to give their address, ask for zip code and county and put a placeholder address, or select "homeless." If they don't want to give their name, put "John/Jane Doe."

*why might they not want to give this information?

(Scenario #6)

A client is having difficulty filling out the form or I cannot read their handwriting.

Offer to assist them, or ask them to tell you the information so you can write it down.



(Scenario #7)

A client is in the system, but a lot of their information is missing.

Either ask them the missing information and input it directly into the computer, or ask them to fill in the missing information on a new registration sheet with their name on it.



(Scenario #8)



I closed out of a client's record too early and realized I made a mistake in it.

Select the orange number next to their name, and it brings you right back to their record. Voila! You can fix it now.



(Scenario #9)




I searched for a client by name, and 2 records came up.

If all the information is the same, mark them to be merged, and then select one of them (ideally the one with the most recent service date) to enter for the day. Mid-Ohio Foodbank will merge them at some point.



PantryTrak Tips

- Always make sure your cursor is **flashing** in the correct box.
- When in doubt, hit the  button
- Don't panic if you make a mistake! Most things in PantryTrak are correctable 😊



Best Practices

- Use a separate room to sign people in, if possible, OR maintain a 10-foot space between client going through intake and the rest of the line.
 - Maintains client privacy.
- Have a volunteer ask waiting clients if they are new and hand out registration forms so they can have them filled out and ready to bring to the intake table.
- Check your entries when there are lulls in the line and at the end of distribution.
 - Look for green boxes (good!). White boxes mean the entry is incomplete. Yellow bubbles mean you forgot something.

Things to Avoid

DO NOT...

- Contact clients for any reason besides alerting them of a food recall, which the Food Bank will initiate with you.
 - If you would like to contact clients for some other reason, please speak to us at the Food Bank first. Because we promise not to use their information, we cannot simply access it for other purposes any time we want.
